### **Medical**

#### **University of Bath**

Towards research and development into measuring diabetic glucose levels non-invasively across the skin.

**£50,000 over three years**

#### **The Cicely Saunders Institute, King's College London (KCL)**

To fund a Sir Halley Stewart Trust African Scholarship – responding to the need for leadership in African palliative care policy, research and practice.

**£42,310 over one year**

Towards the project *Bio-Scaffolds in the treatment of diabetes: A novel means of implanting immune-modified human islet*.
